

For all other orders we will issue a credit, with prior approval, if returned to A.K. Draft Seal Ltd. within 90 days from date of invoice and it is in resalable quality, size, and condition. No returns will be accepted after 90 days from date of invoice. No cancellations accepted on special or custom orders where work is in progress. Customer is responsible for freight charges on return goods.

All thresholds up to 48" are supplied cut 1/2" over and all 60" and over are supplied cut 1" over. Where exact lengths are required, state length followed by "NET". Less than 36" charged as 36". Cut lengths over 12 ft charged as 15 ft. Most extrusions are available in 12ft and some in 15ft lengths. Please inquire.

DRILLING, PUNCHING & SCREWS

Threshold price includes punch and counter sunk holes with appropriate length and style of screws and plastic shields. Weatherstrip price includes slotted holes and appropriate length and style of screws.
